
## 2020 SESSION REVIEW

March 23<sup>rd</sup> — Assembly Adjourned for Spring Break

April 27th - Full Assembly Reconvened

May 15<sup>th</sup> - Adjourned



# EXPANSION OF EMPLOYEE CONTRIBUTION OPTION BILL

Provides the added options to employers to elect a 2% or a 6% employee contribution amount in addition to the 0% or 4% options.

Allows separate contribution election if an employer covers Social Security-participating employees and Non-Social Security-participating employees under separate benefit multipliers.

Brought to the General Assembly after discussion with LAGERS' members and stakeholders.



## EXPANSION OF EMPLOYEE CONTRIBUTION OPTION BILL

- LAGERS filed companion bills: Senate Bill 768 (Onder) and House Bill 1467 (Pike)
- House Bill had it's first hearing on the 4<sup>th</sup> day of session and was Third Read and sent to Senate on Feb 3<sup>rd</sup>.
- Senate Bill had a hearing, but was never voted out of Committee.

## EXPANSION OF EMPLOYEE CONTRIBUTION OPTION BILL

- When the General Assembly reconvened, HB 1467 was taken up in Senate Health & Pensions and voted out.
- Meanwhile, our language was amended onto SB 599 in the House and was TAFP.
- HB 1467 was rolled into a mini-omnibus pension bill in the Senate and was TAFP.

#### **Legislative Advisory Committee**

LAGERS Legislative Advisory Committee was created in 1973 to provide a forum for interested members and employers to review possible legislative changes in LAGERS. The Committee meets at least once a year in conjunction with LAGERS Annual Meeting to discuss upcoming legislative priorities, and to vet through any new policy proposals.
